## Response:

Odyssey invites all parents to become active members of our learning community. We encourage parents to partner with us to help provide a supportive and positive learning experience for every child. As part of each family's commitment to their child's education, parents commit to a minimum of eighteen volunteer hours each school year. Parents are provided with various opportunities to partner and support our children, such as becoming members of our School Advisory Council (SAC), participating in our parent volunteer organization, Parents as Partners (PasP). Parents are invited to become members of the School Advisory Council by notification of Odyssey's school newsletter. Interested parties submit a short biography which is shared with stakeholders and a majority vote is taken to admit members. Every effort to create a committee representative of our school population is made. SAC members assist in the development, revision, and review of the School Improvement Plan (SIP), Parent and Family Engagement Plan (PFEP), and the School-Parent-Student Compact. Parents also contribute to the development of our programs by providing feedback which is used in planning and developing future programs. ## **Annual Parent Meeting:**

To meet the needs of our school, families and students Odyssey K-5 will provide three nights for our Annual Title 1 Parent meeting. This helps to eliminate the barrier of parking for this campus. Odyssey 6-12 offered one night since parking isn't a concern on their campus. Families were invited through a paper invitation, on our LED marquee, through social media including Facebook and Remind and through the Blackboard internet option.

During the evenings, parents were introduced to the teachers and staff that were there to support their children. A PowerPoint was presented to the parents sharing all the Title 1 requirements, rights of parents and students as well as the school's data and expectations. Families were introduced to our Parents as Partners contact and were given information about upcoming meetings and to assist them with volunteering throughout the year. Information was given about translations and programs available to assist our Hispanic families.

An information gathering survey was given and collected from parents to help each school to ensure parent feedback was utilized in creating the 2018-19 School Improvement Plan. Parents were also asked to complete a short exit survey to let the school know if the needs of the family were met in the

presentation and evening.

#### Response:

Odyssey's leadership team understands the value of parental involvement and recognizes the connection between parental support and student academic success. To build upon our current parental support and involvement, we've implemented several opportunities for parent participation. We offer various opportunities for families to receive pertinent information on a frequent and repeated basis. Parents will be provided with the opportunity to mingle with the members of our administrative team, teachers, Title 1 staff, and support team members in a friendly social environment during the Annual Title I Meeting. This will be an opportunity to take advantage of the large parent turn out, where parents will be provided with information relaying the importance of family involvement and to share our passion to partner with parents for the success of every child. Our administrative team works closely with our SAC members, which includes parents and community members, to plan opportunities throughout the year where we can distribute information to our families regarding Odyssey programs and events. As many of our parents have work and/or family commitments in the evening we make every effort to accommodate our families and offer before, during, and after school meetings. Our evening programs are made available later in the evening to allow for parents to have the ability to care for their children and attend Title 1 offered meetings and programs. In addition, we provide information on these programs and events via Odyssey's parent e-mail newsgroup, the school's website, social media sites, the school's marquee sign, monthly school newsletters, and direct mailings.

At the Title 1 Annual Meeting, a Parent Involvement Survey was shared with families to collect information that will guide our family engagement events throughout the year. At these Title 1 Annual Meetings we had most of our families attend due to the fact that we combined the Annual meeting with our Open House for each grade level. This offered us a full contingency of families to give us ideas and ways we can support them throughout the year. Odyssey is looking at ways to partner with our neighborhood churches and businesses to bring volunteers and support to our school and for our families. We have partnered with Brevard Health Alliance and Big Bear Counseling to provide outside services for our families in need. During our Title 1 academic nights we will provide the families with strategies and activities that they can take home and use with their child, for example, vocabulary or comprehension strategies that can be used by all as the students are reading or doing homework. As needed, translation services will be provided for Parent/Teacher conferences, IEP or 504 meetings or family events where translation is needed. Odyssey employs a Family Engagement Specialist/Volunteer Coordinator that will assist families by providing information about any Parenting/Family events. This contact will also assist the school in locating Volunteers that can work with our students in the classrooms providing not only academic help but also another mentor that can help to guide the students.

### Response:

Teachers and staff have training in positive discipline during pre-planning and throughout the year which helps with understanding the importance of problem solving and conflict resolution. During the training it is stressed the importance of communication and building partnerships with parents. Staff will also be trained in Crisis Prevention De-Escalation to assist with dealing with students and families in crisis/trauma. During pre-planning staff discuss with their teams and the whole staff on ways to effectively communicate with parents. Teachers were given communication logs and trained on the use of them and the importance of positive communication with our families on a weekly basis. Throughout the year e-mail reminders and verbal reminders are given in staff meetings. Throughout the year at staff meetings Teachers are asked to discuss and brainstorm effective ways to reach children and parents. The School Guidance Counselor will train the staff on our Mental Health plan and on services that are available to assist the families and students.

#### Response:

Odyssey Charter School tracks all required Title I Documentation as required by Federal Guidelines. Documentation is completed by identifying students, dates, and the method in which documentation is disseminated. Odyssey has created and will make available in our front office the Title 1 binder. Parents will be provided with information pertaining to all Title 1 programs, events, and offerings at both the school and district. In addition, the Parent Involvement plan will be made available on the school's website, along with other pertinent information such as the School's Improvement Plan. Teachers will keep parents informed of ways they can help support student learning by sharing out current happenings in their monthly classroom newsletters. In addition, Odyssey will hold a Parent FOCUS information meeting and encourage all parents to attend. Parents will have the opportunity to access and set up their parent accounts to their child's(ren is) FOCUS account. The importance of being informed on the academic progress of their child(ren) will be shared. After Title I activities such as the Title I Math Night, Annual Meeting and Science Information night, all families are given a survey to which they are asked if they feel the information provided was helpful; do they feel more knowledgeable and feel they can support their student better from the material that was presented; was the meeting scheduled at a convenient time, etc...

## Response:

At the Annual Title I meeting, parents will receive information about the Title I program, curriculum, academic assessments, and grade level expectations. Copies of all handouts and presented information will be made available and provided to any parent who requests, that is not able to attend the meeting. This information as well as Odyssey's School Improvement Plan will also be made available to parents via Odyssey's website and can be located under the parent tab. For parents who are unable to attend their child's(ren's) Open House event, classroom teachers will send packets of information shared home with students the following day. All information given at the Title 1 Annual meeting will be put together to give to all new families that join Odyssey after the September dates. Parents are encouraged to attend scheduled parent conference nights on November and January. Our classroom teachers are also available to conference before school, during their planning time and after school to accommodate parents' scheduling conflicts. FOCUS will be used as an additional source of communication between school and home and all teachers are responsible for updating it regularly. Students in 3rd-6th grades receive daily planners for homework recording or parent notes. Yearly calendars go home with every student and bi-monthly school and classroom newsletters keep parents informed of happenings in our building. Other forms of communication that are used include, the school website, school marguee and car loop signs. In addition, social media will be used to communicate and invite families to events and to share information those will include; Remind App and our school Facebook Page for parent communication. The school uses Blackboard and the Google News Group as well for email and/or phone communication.

The brochure will offer to provide a hard copy of the PFEP in its entirety through Odyssey's front office and additionally posted on Odyssey's school website. Odyssey Charter will provide full opportunities and accommodations will be made, to the extent feasible, for participation of

parents with limited English proficiency, parents with disabilities, and parents of homeless and migratory children at our family and community events.
